

About Renting

All charges are for time out, whether used or not. Please make your selections carefully.

Pricing

Most prices quoted are for a one day charge, if you desire to use rental items for a longer period, please call our office for long-term rates. Please reserve items in advance to assure availability. Rental payments will not be applied toward any purchase of lost or damaged equipment.

Order Changes

Any changes must be made at least 48 hours prior to delivery or in house pick-up. Cancellation must be made two weeks prior to the day of the rental. A separate contract is used for wedding related events.

Deposit

Security deposits are required at the time of the reservation and are based on the total amount due. Increased orders will require additional deposits. Security deposits are not applicable to the rental total. Security deposits will be returned in full 2-4 weeks after verification that all equipment was returned in the same condition it was sent. Security deposits may take longer than 4 weeks to return during high volume.

Delivery

Delivery is available at a reasonable charge in the metro area to your property line unless arranged in advance. Set up and take down of equipment are additional fee. Delivery is to ground floor only.

Pick-Up

All china, silver, flatware, and small wares, etc, should be free of food and replaced in their delivery containers. Linens should be refuse free and air dried to prevent staining and mildew. Tables and chairs should be taken down and stacked ready for pick-up. All items should be stored in a single location as specified above, ready for pick-up. Items not meeting these conditions are subject to additional charges.

Set Up-Take Down

Set up and take down service is available at an additional cost if arranged in advance.

Loss or Damage

Responsibility for equipment remains with lessee from time of delivery to time of return. Please be sure equipment is secured when not in use and protected from the weather. We do charge for missing or broken items. The replacement cost will be charged against the security deposit. In the instances that a deposit is not applied to the invoice or the damage(s) exceeds the amount of the deposit; the credit card that is on file will be charged. Damaged items will be held only for 30 days for customer.

Late Returns:

All orders not returned on the due date listed on the invoice will be charged a flat-rate late fee of \$25.00 per day. Any orders that are returned after the due date listed on the invoice are subject to additional day(s) of rental charges. Late returns may impact other rental orders.

Terms and Conditions

1. Rentals are cash in advance
2. Excessive dirtiness may result in a cleaning charge. A \$.15 per dish fee is charged for dishes and a per hour charge to remove wax from tablecloths or candelabra will be assessed.
3. Renter agrees he will pay for time out.
4. Renter agrees he is renting for personal account or person or entity for whom he is a duly authorized agent.
5. Renter agrees he will hold harmless Marianne's Rentals for Special Events, Inc. from liability from his use or use by any person known or unknown to Marianne's Rentals for Special Events, Inc.
6. Renter will discontinue use of described property in severe weather or if equipment becomes unsafe or in a state of disrepair.
7. Renter agrees excess damage beyond damage occurring from normal usage will be paid by him.
8. Renter's right to possession terminates at the expiration of rental period and continued possession is a breach of contract. Time is of the essence. Contract may be renewed by notification and payment of additional fees.
9. There are no warranties expressed or implied of merchantability or fitness or warranty that equipment is safe or suited for customer's intended use.
10. Renter agrees Marianne's Rentals for Special Events, Inc. may terminate contract and repossess on failure to pay or any other breach of contract.
11. Failure to return merchandise after 10 days beyond expiration of contract is cause for legal action by Marianne's Rentals for Special Events, Inc. Renter agrees to pay all collection fees, court costs, and attorney fees to enforce terms of this contract.
12. Marianne's Rentals for Special Events, Inc. retains the right to terminate the contract at will without liability in the event of dispute occurs and no reasonable agreement is reached.
13. This contract supersedes all oral agreements.
